Subject: Enforcement of 3M, Oosterweel and Indaver

1 ENFORCEMENT OF 3M, OOSTERWEEL AND INDAVER

In 2021, a severe PFAS pollution was discovered at the industrial area of 3M while redeveloping part of the traffic infrastructure around Antwerp, called Oosterweel. The findings at 3M and the Oosterweel works led to specific enforcement actions at 3M, at the site of Oosterweel and at the waste processing company Indaver, where PFAS-containing waste is processed. During this session, several enforcement officers shared their experiences and gave insight in the problems that arised, both at these companies and in the enforcement itself.

2 <u>Q&A's</u>

Several questions were launched via Slido and after the presentations. All questions were answered during the session.

Main point of discussion was the lack of validated analytical methods for the measurement of the PFASemissions in water, soil and air and also the lack of limit values of the emission of PFAS. This makes big challenge for the enforcers when confronted with PFAS-pollution and -emissions.

Nevertheless, due to a good cooperation with VITO, VMM, OVAM and the department of Care is it possible to tackle these problems and to enforce a reduction and remediation of the PFAS-emissions.
